"AUTONOMY STATUTES AND REGIONALIZATION: SOLIDARITY AND EQUALIZATION BETWEEN REGIONS"

Palais des Nations (Room VIII), Geneva, 1st July 2013, from 12.30 to 15.00

Background

On **11 April 2007**, the Kingdom of Morocco tabled with the Secretary-General of the United Nations a document entitled "Moroccan Initiative for Negotiating an Autonomy Status for the Region of Sahara" meant to put an end to the current impasse on the negotiations regarding the status of Western Sahara. ¹ In order to promote discussion on some aspects of this proposal, Morocco initiated, among others, four international academic seminars:

- One on **6 October 2009** in Geneva (Switzerland) at the Geneva Centre for Security Policy (GCSP), which published a synthesis of that event in its *Geneva Paper No.* 12²;
- The other on **21-22 February 2011** in Dakhla (Morocco), on the Human Rights and Democracy dimensions of the Moroccan Initiative, whose results were presented to a roundtable on 17 March 2011 in the margins of a meeting of the Human Rights Council in Geneva, and were published by the Moroccan Ministry of Foreign Affairs and Cooperation;
- A third one on 22 March 2012 in Geneva on "Governance in Autonomy Statutes: Institutions and Mechanisms";
- A fourth one on **4 June 2012** in Geneva on "Managing Natural Resources in Autonomy Statutes". Morocco has published the proceedings of the 2012 seminars.

Morocco organises a new international research seminar on **1**st **July 2013** on "<u>Autonomy Statutes and Regionalization:</u> Solidarity and Equalization between Regions".

This event, like the previous ones, aims at promoting the importance of the Moroccan Initiative as an unprecedented model for managing autonomy in the context of North Africa but also likely to serve as reference in other countries of the Global South. This seminar will indeed offer an opportunity to compare practices in some countries aiming to ensure an equitable distribution of resources and revenue between the central government and the autonomous region(s) with the provisions proposed by Morocco for the Sahara Region. It is however important to note that the international negotiations on the status of Western Sahara are being conducted within the framework of the United Nations and that this seminar does not intend to appear as a substitute of such negotiations.

Simultaneous interpretation and translation of all documents and papers in English and French will be ensured. The proceedings of the seminar will be published by Morocco.

BIOGRAPHIES OF SPEAKERS

Michel BOUVIER

Professor Michel Bouvier is Director of the Master programme on Law and Public Finance at the Paris 1 Panthéon-Sorbonne University, and runs the Public Management module at the National Heritage Institute. He also teaches within the Preparatory Cycle for recruitment into the National Government School (ENA) and is a member of ENA's juries. He is the founder and Director of the *Revue française de finances publiques* journal as well as the European Group on Public Finance Research (GERFIP), and Founder-President of the Association for the International Foundation on Public Finance (FONDAFIP). He directs several collections of publications, is a member of various organisations (Observatory of Local Finance of the Committee of Local Finance, Experts Committee of the Delegation on Local Government and Decentralization of the French Senate, Advisory and Orientation Committee of the Council for Standardization of Public Accounting, Council on Taxation and Contributions, Overseas Territories of the French Agency for Development, Observatory of Public Spending, Board of the French Society for Public Finance, Editorial Council of *Revista international de Direito Tributario* —Brasil—, Editorial Board of *Revista de Finanças publicas e direito fiscal* —Portugal— and *European Tax Studies*). He authored many publications, including "Local Financial Autonomy: A Tested Concept for the 21st Century", in *Revue Française de Finances Publiques* (May 2011) and "Decentralization, Financial Autonomy and Taxation Powers in Local Government", *FEACT* (April 2009).

Gyula CSURGAI

Born in Budapest, Dr Gyula Csurgai holds Swiss and Canadian citizenships. He holds University degrees in Political Science from Concordia University, Canada and the University of Toulouse, France. He obtained two Master degrees from the University of Geneva and a Diploma in French Language and Civilization. He obtained his doctorate degree from the University of Geneva, completing his thesis in the field of geopolitics. He worked as a Fellow at the Geneva International Peace Research Institute (GIPRI), and has taught International Relations, Geopolitics and Geoeconomics in both undergraduate, master and doctorate programmes at different universities. He also organized seven international symposiums and directed the publications of their proceedings. He participated in several international research projects and provided expertise to a number of international organisations. He is co-founder and Director of the International Centre for Geopolitical Studies and Academic Director of the International Studies programme of (School of International Training (SIT) University in Geneva. José María DURÁN-CABRÉ

Dr José María Durán-Cabré is Associate professor at the Department of Public Finance, Faculty of Economics and Business, University of Barcelona since 2007, a Research member (since 2000) and Chief executive officer (since 2006) of the Barcelona Institute of Economics; he has been External advisor to the Government of Andorra in 2009-2010. From the University of Barcelona (UB), he received his PhD in Economics in 2002, his BA in Law in 1997, his BA in Economics in 1994 and his MSc in Fiscal Studies from the University of Bath (UK) in 1998. He teaches Public Finance and Spanish Tax System at the University of Barcelona (since 1995) and Economics of Taxation at Universitat Oberta de Catalunya (UOC) since 2008. His research experience includes projects on: Fiscal Federalism and Regional Economy; Tax assignment and fiscal decentralization; Tax reform in Andorra; the Spanish experience in the administration of the personal income tax: tax data sendings and pre-filled tax returns; Financing the new competences of local governments; Evaluation of the effects of decentralization on the efficiency in the provision of public services and democratic government accountability; Fiscal Federalism and Regional Economy; Fiscal Federalism and Regional Economy; The financing system of autonomous communities: a proposal for a system of equalization grants. Marie-Madeleine MIALOT

Ms Marie-Madeleine Mialot-Muller is a French local government elected representative, currently Vice-President of the Regional Council of the Centre Région (headquartered in Orléans), where she is in charge mainly of urban planning, de economy and agriculture. She also fulfils the functions of Representative of the Chamber of Regions and First Full Member of the Governance Commission of the Council of Europe, where she is a member of the Socialist Faction. She is also Rapporteur on Decentralisation of the Congress of Local and Regional Authorities of the Council of Europe, which is a pan-European political assembly composed of 636 members – regional and local councilors, presidents of regional councils – representing more than 200,000 local councils from 47 European countries. As such she took part, among others, in international missions, for instance on monitoring local elections in Armenia or discussion of decentralisation by the Tunisian Constitutional Assembly.

Jean-Louis ROY

Jean-Louis Roy is visiting researcher at the Research Centre in Public Law of the University of Montréal (CRDP) and a member of the Board of the Centre for International Studies and Research (CERIUM). One of the main architects of the institutions of international Francophonie, Mr Roy was, from 1990 to 1998 the Secretary General of the Agency of Francophonie, uniting 49 States and governments. In the 1980s, he was the Director of the Montreal daily newspaper *Le Devoir*, and then Delegate-General of the government of Quebec in Paris. From 2002 to 2008, Mr Roy was the chairman of *Droits et Démocratie* (International Centre for Human Rights and Democratic Development). As a historian, he authored in particular *L'Europe au XXI^e*, *La Francophonie : Le Projet communautaire* and *Une Nouvelle Afrique à l'aube du XXI^e siècle*.
